





### **Payment Terms**

a. The reservation fee is set at 70% of the total price and is non-refundable due to pre-booking commitments and the airline's non-refundable policy.
b. The remaining balance of the land arrangement costs must be fully paid at least 30 days before the scheduled tour.
d. For trips booked less than 30 days before the tour date, full payment is required immediately to finalize the booking.
d. By sending the payment, the customer acknowledges and accepts these terms and conditions.
e. Refunds, if applicable, will be sent back to the same account from which the payment was originally received. Any request for a refund will be subject to our terms and conditions.

### Same-Day Refund Requests:

All payments are non-refundable once sent, even if requested on the same day, due to pre-booking arrangements.

However, if a same-day refund is requested within 2 hours and before any reservations have been finalized, a partial refund may be granted, deducting a processing fee of 20% for administrative fees.

### **Children's Discounts:**

### **Health and Safety**

### **Minor Passengers:**

a. Parents or legal guardians must accompany minor passengers under the age of 18.

b. If a guardian accompanies the minor, a clearance from the Department of Social Welfare and Development (DSWD) is required.

### **Health Conditions:**

a. Travelers must disclose any existing health conditions or concerns that may affect their trip with the travel company. b. Changes in health conditions must be promptly communicated.

### **Medication:**

Travelers with pre-existing conditions are responsible for bringing necessary medication and managing their health during the trip.

#### Liability and Insurance:

a. Tara Travel Co. is not liable for injury, death, loss, or damage of valuable items during the trip.

### **Flights and Immigration**

### **Travel Documents:**

a. Travelers are responsible for ensuring they possess valid travel documents, including passports and visas.

b. Passports must be valid for at least six months upon departure and arrival and must not be tampered with or damaged.

### **Immigration Decisions:**

### **Hotel Policy Room Allocation:**

### **Booking Confirmation:**

a. Hotel bookings will only be confirmed upon full payment. b. If the preferred hotel is unavailable, a similar-class hotel will be booked.

### **Incidental Deposit:**

An incidental deposit, dependent on the room category, is required upon check-in and is refundable upon check-out if no additional charges are incurred.

### **Check-In and Check-Out:**

a. Standard check-in time is 2:00 PM onwards, and check-out time is 11:30 AM–12:00 PM.

b. Early check-in and late check-out are available on a case-by-case basis and may incur additional charges.

### **Rebooking and Cancellation Policies**

1. More than 30 days before the trip: Free one-time rescheduling. The

- 6.No refunds for passengers unable to pass immigration or those who miss their flights.
